BYLAW NO. 420

A BYLAW FOR IMPOSING TAXES UPON LANDS IN THE DISTRICT AND FOR PROVIDING A PERCENTAGE ADDITION TO ENCOURAGE PROMPT PAYMENT THEREOF.

The Trustees of the Kaleden Irrigation District **ENACT AS FOLLOWS:**

1. For the year 2023 there are hereby levied the following taxes:
 - a. A tax rate of \$69.00 (sixty-nine dollars) per parcel on all parcels of land classified into Group 1 (a).
 - b. A tax rate of \$103.50 (one hundred & three dollars and fifty cents) per parcel on all parcels of land classified into Group 1 (b).
 - c. A tax rate of \$161.00 (one hundred & sixty-one dollars) per parcel on all parcels of land classified into Group 1 (c), except those lands registered as Lot D, D.L. 104s, Plan 30183.
 - d. A tax rate of \$228.00 (two hundred & twenty-eight dollars per parcel on all parcels of land classified into Group 1 (d).
 - e. A tax rate of \$228.00 (two hundred & twenty-eight dollars) per acre on all parcels of land classified into Grade A (1), except those lands registered as Lot 1, DL 104s, Plan 17568.
 - f. A tax rate of \$167.20 (one hundred & sixty-seven dollars and twenty cents) per acre on all parcels of land classified into Grade A (2).
 - g. In addition to those taxes set out in Clauses 1 (a), (b), (c), (d), (e) and (f), a tax levy of \$250.00 (two hundred & fifty dollars) on all parcels of land classified into Groups 1 (a),(b),(c),(d) to which domestic water is supplied and Grade A (1), and Grade A(2), to which domestic water is supplied.
2. The taxes set out in Clause 1 shall be due and payable on or before the 1st day of October 2023, and a percentage addition of 10% of the amount thereof shall be added to any such tax remaining unpaid after the said due date. An additional percentage of 10% shall be added to any unpaid taxes after the 31st day of December 2023.
3. In addition to the above, taxes remaining unpaid on the 1st day of March, 2024 shall thereafter bear interest at a rate prescribed under the Taxation (Rural Area Act) as set out in Section 717 of the Local Government Act, until paid or recovered.
4. This Bylaw may be cited as the First Taxation Bylaw 2023.
